I am currently engaged in a one-year post-doctoral fellowship position (T32) which is an Alcohol Research Training Grant, titled "Alcohol Research Training: Change Methods & Mechanisms. The goal of the grant is to prepare future NIH scientists to conduct research to (1) elucidate the processes of change in drinking behavior, (2) develop and test effective methods to effect change through self-change, treatment and indicated prevention, and (3) develop and test models to disseminate knowledge of effective interventions for diverse populations. I will be incorporating research questions on housing and homelessness into existing scopes of work and new grant applications.

Although the course is designed for a face-to-face format, I have adopted material to work online as well. I have taught over 300 students over eight semesters.

Research Assistant (2014-2019) University of New Mexico, Albuquerque, New Mexico At UNM, I have worked on an NIMHD-funded R01 study that tests the effectiveness of an innovative, community-based advocacy, learning, and social support intervention (Refugee Wellbeing Project) to reduce the mental health disparities experienced by low-income refugee adults by addressing several well-defined social determinants of mental health and increasing refugees' engagement in trauma treatment, when warranted. I conducted interviews and performed qualitative and quantitative data analysis.
